1. ATTENDANCE

3. MINUTES OF PREVIOUS MEETING

3.1 The accuracy of the minutes of the Parish Council Meeting held on 15th May 2023 were agreed & they were adopted & signed by Cllr Kyriacou.

4. PUBLIC FORUM

4.1 GYBC CIIr James Bensly, Borough Councillors – Thanked the Parish Councillors that re-stood in the May 2023 election. GYBC Armed Forces Day today. GYBC are going to be using social media to raise awareness of dogs in hot cars & that anyone should call 999 for advice. CIIr Bowgen advised that this had happened last week at the Car boot sale, where a dog had been left in the car. 'The Wheels' event is running next week. The loneliness campaign is coming to an end but residents can still be supported, the Pension Credit calculator is available on line if you want to see how much pension you may get.

NCC Cllr James Bensly School appeals panel Is looking for new members, there is refill revolution project going on around the county where you can take an empty bottle & get a free water refill. There is a huge shortage of foster carers in Norfolk & children are being placed outside of the county. 4.2 Police – Gary May not present, there had been a SNAP held at Scratby Village Hall, Beach Road, Scratby, on Thursday 8 June 2023.

4.3 To receive comments from members of the public. A letter was read out from Hemsby Village Hall to thank the Parish Council for the grant that they received for the Coronation event (£350) that they held, 45 children attended, with food & drink included. The Village Hall Committee topped up the fund to cover the remaining costs.

It was **resolved** to move item 8.3 to exclude members of the Press & Public to discuss the item.

5. **NEIGHBOURHOOD PLAN**

5.1 The Neighbourhood Planning Group advised that the referendum will be held on 22 June 2023 at the Village Hall, Waters Lane, Hemsby. The question for the referendum has been published on the noticeboards & facebook page. 'Do you want Great Yarmouth Borough Council and the Broads Authority to use the Neighbourhood Plan for the parish of Hemsby to help them decide planning applications in the neighbourhood area?' The hours of poll will be from 07:00 to 22:00.
5.2 GYBC have asked for names of Cllrs wishing to attend the counting of the referendum ballot papers on Wednesday 22nd June 2023 at 10pm at the Village Hall. It was agreed that Cllr Bowgen, Cllr Kyriacou, Cllr Chilvers & Cllr Kern would attend & the clerk will inform GYBC. -Action Clerk

6. CORRESPONDENCE

- 6.1 It was noted that a letter has been received from Fengate Farm Livery requesting a 'Caution Horse' sign for Common Road & it has been passed on NCC Cllr James Bensly. He advised that this is being paid for from his NCC Highways budget & will be installed shortly.
- 6.2 It was noted that complaints have been received & an MP's letter about the grass in the Chuch yard, this has been passed on to GYBC. The Parish Council have also been contacted by GYBC following the last site meeting & although we had been led to believe that they were seeking further solutions, although it appears from a subsequent email that this may not now be the case, it was agreed that this would be added to the July agenda.

- 6.3 It was noted that complaints had been received about the height of the grass verges at the Collis Road/ Martham Road junction & Pit Road as it is obscuring vision, they were passed on NCC Cllr Bensly & the NCC Highways area team. This area has now been cleared.
- 6.4 It was noted that an expression of interest had been submitted to the Community Ownership Fund (Government Department for Levelling Up, Housing & Communities) for a grant to refurbish the tennis court into a Multi Use Games area (MUGA) the application has been declined.
- 6.5 GYBC Cllr James Bensly is organising a beach clean, the location: Hemsby Beach Cafe, The Marrams, Beach Rd, NR29 4JN. Date: Saturday 24th June. Time: From 10:00am till 1pm, to remove the building materials that have been washed up during the storm damage, this has been instigated by Ormesby & Scratby Parish Council, but the access will have to be via Hemsby as there is no other way to get to it.
- 6.6 It was noted that a complaint has been received about the Public Toilets on Beach Road, they had been re-directed to GYBC, who have responsibility for their own toilets.

7. ADMINISTATIVE/DAY TO DAY MATTERS

- 7.1 The contents of the Clerks report were noted.
- 7.2 The clerk advised that a letter has been sent to the householder behind the existing bus shelter to advise them of the replacement project & no contact has been received. It was agreed that an order should be placed shortly to give the householder time to respond.
